Our long dream of setting up a separate revolving fund for women has been realized this year. Our FCRA has been renewed on 1-4-2023 and its validity remains till March 2028. We have applied for our NGO with Social Stock Exchange (SSE). Our staff team has been expended this year. A number of enterprising activities such as tailoring, jute bags making, wire bags weaving enabled many women to get the training and this program built the self confidence of women in learning new skills and opportunities for employment.

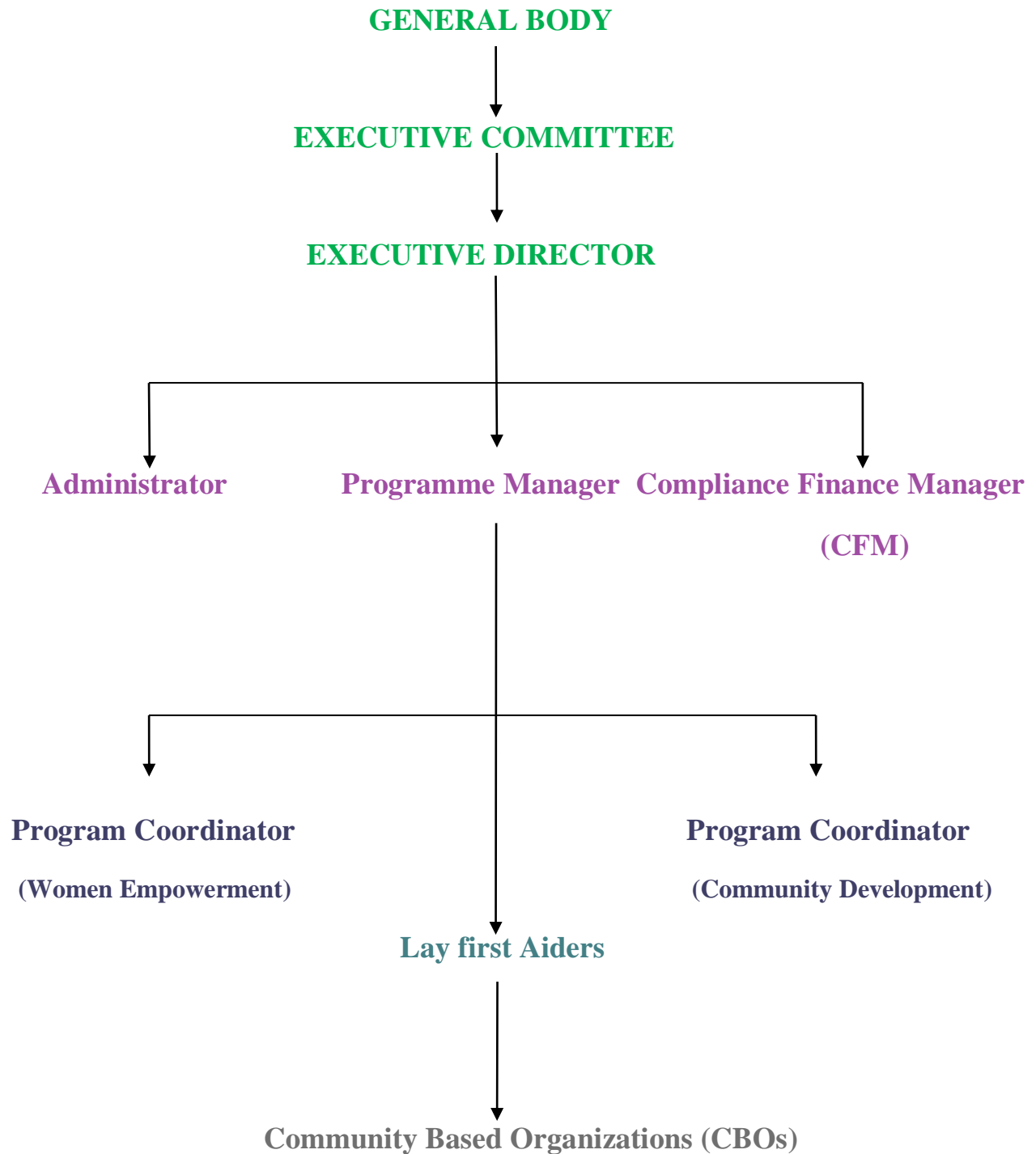

## **INTRODUCTION ABOUT ORGANIZATION**

ASSCOD is a non-profit, registered Association, Registered under Tamilnadu Societies Registration Act. The Registration number of the organization is 111/1994. The organization is registered under Foreign Contribution Regulation Act (FCRA) of 1976 and 2010. Our organization renewed its FCRA registration with Ministry of Home Affairs to receive foreign contribution and the renewal is valid till March 2028. Our NGO has exemption status under sections 12A and 80G of Income Tax ACT. ASSCOD is empanelled with TATA Institute of Social Sciences (TISS) CSR Hub and National Foundation for Corporate Social Responsibility (NFCSR), Ministry of Corporate Affairs. Our NGO is approved through registration of CSR Form-1 to receive CSR Funds as per recent amendment in CSR Laws 2021. Our NGO has applied to list with Social Stock Exchange (SSE).

Our organization helps in promoting and developing the socio-economic conditions of people in rural communities. Initially, our priority was to provide healthcare facilities to people living in remote areas, and then we shifted our focus to empowering rural women as they were subjected to gender inequality, domestic violence, and no access to livelihood opportunities.

We, as an organization believed that empowered women play a crucial role in families and community development. So, our development projects aimed towards capacity building of women and enabling them to access services to attain social and economic empowerment. Our NGO extended services to provide educational support for children from underprivileged communities.

### **VISION:**

Economically empowered rural women below poverty line to lead their families and bring prosperity to the Community.

## **MISSION:**

To work with rural women through Self Help Groups (SHGs) by imparting training including financial literacy to enhance their economic skills and to increase their income to attain economic and social empowerment of the groups. Thus, enable women as agents of social change and empowering them to lead the prosperity of their community.

## **HIGHLIGHTS OF THE YEAR 2023-24**

- ❖ Formed a trust named Wings to fly trust to benefit 374 Tribal women exclusively in 15 villages of Chengalpattu and Kanchipuram Districts of Tamilnadu. This is an independent body being run by tribal women with the facilitation support of ASSCOD.
- ❖ Disbursed interest free micro loans to benefit 205 tribal women to the amount of Rs.55,39,000.
- ❖ Trained 72 women in livelihood skills development such as tailoring, wire bag and jute bag making.
- ❖ Set up 3 new enterprises known as wire bag making unit, jute bag making unit and tailoring unit and employed 72 trained women.
- ❖ Set up RO plant at Girls Higher Secondary School, Madurantakam and Pudupattu Panchayat to benefit 1500 children and 2000 people.
- ❖ Donated 1550 Portable Solar Lights (PSLs) to benefit 1550 Tribal families in Chengalpattu, Kanchipuram, Dharmapuri and Nilgiris District in Tamilnadu and Chamrajnagar District in Karnataka.
- ❖ Ran 6 evening tuition centres (Engagement centers) benefiting 115 Scheduled Tribe and Scheduled Caste children in Madurantakam Taluk of Chengalpattu District.
- ❖ Revised our Vision, Mission and Values statements to align it with the Objectives and Sustainable Development Goals (SDGs).



## **A note on Sustainable Development Goals and ASSCOD Commitment to achieve SDG.**

In the year 2000, UN developed 8 Millennium Development Goals (MDG) to address the key development issues such as poverty, primary education, infant mortality, maternal health, gender equality and environment. ASSCOD was keen on addressing development issues based on Millennium Development Goals devising key activities. It implemented activities to attain poverty eradication, achieve universal primary education, and improve maternal health through implementing a project titled capacitation of women for sustainable development. Based on Millennium Development Goals, we enabled 3128 Below Poverty Line (BPL) to come out of poverty, improve health and education attains gender equality and promoted environment in the 26 villages of Vandavasi and Cheyyar Taluk of Thiruvannamalai District.

## **Sustainable Development Goals (SDG) – 2015-2030**

United Nation (UN) developed another set of Goals known as Sustainable Development Goals (SDG) to achieve it by 2030. Our NGO started to implement the following goals by devising our own activities.

# **PROJECTS**

## **1. Women Empowerment**

ASSCOD has been working since 2000 to empower the rural women in Chengalpattu, Kanchipuram and Thiruvannamalai Districts of Tamil Nadu. We implemented a project titled Capacitation of women for sustainable development and enabled about 4000 women from Below Poverty Line (BPL) families and mostly belong to Schedule Caste and Schedule Tribes to come out of poverty. We formed and developed about 400 women Self Help Group (SHG) and built the capacity of Self Help Groups to implement activities based on millennium development course. We have completed this project in the year 2015 ensuring women from 3128 Below Poverty Line (BPL) families to come out of poverty. As both Central and State Government started to bring the Self Help Groups under their fold through forming Panchayat Level Federations (PLF), we struggled hard to enable our groups to open bank accounts. In this context, our NGO felt that forming Self Help Groups (SHGs) would duplicate the Government work. Hence we stopped forming SHGs.

## **2. Livelihood enhancement of tribal women (Wings to fly Project)**

Despite our NGO worked to empower the women in rural areas for a longer period, we failed to cover the women from tribal villages. Tribal women have been in extreme poverty and no Government programmes or NGOs programme reached them to prosper their life. In this situation, we had an opportunity to work with Omega Healthcare and with the financial and technical support, we started a project titled “livelihood enhancement of tribal women”. The aim of the project is to enable tribal women in 15 villages to come out of poverty.



## Key Achievements

- Identified 15 tribal villages in Chengalpattu and Kanchipuram Districts of Tamilnadu
- Identified 374 tribal families in 15 villages and formed 15 Mahlir Grama Sabhas (Community Based Organization).
- 205 tribal women were disbursed interest free micro loan for the amount of Rs.55, 39,000
- Formed a trust known as Wings to fly trust to serve the tribal women exclusively
- Drinking water programme benefitted 3520 poor people
- Health programme benefitted 9562 poor people
- Portable Solar Lights (PSLs) benefitted 1500 poor tribal families

## **Case Study 1:**

### **Introduction:**

Meet Meena, a 25-year-old resident of Elapakkam village, facing the challenges of providing proper food, clothes for her family members. Her husband, Saravanan, worked as a daily wage laborer. The introduction of ASSCOD's micro credit program by Omega Healthcare presented a golden opportunity for Meena to create a sustainable source of income and support her family.

### **Challenges Faced:**

Meena, with a 2-year-old daughter and her husband's income as the sole financial support, struggled to meet the growing needs of her family. She sought a way to contribute to the household income while caring for her child.

### **The Intervention:**

Upon learning about the ASSCOD micro credit program, Meena made a strategic decision to invest in goat rearing, a skill she was already familiar with. With the micro credit, she acquired 2 goats and also entered into a unique arrangement to rent 2 more goats. The rental agreement stipulated that if the rented goats produced 2 kids, one kid would go to the owner, and Meena would keep the other.

### **Investment and Results:**

Meena's 2 goats successfully gave birth to 4 kids, and the rented goats added 2 more, resulting in a total of 8 goats. Priced at Rs.5000 per goat, she sells each goat for Rs.8000, realizing a profit of Rs.3000 per goat. Additionally, Meena has 6 kids for rearing, further contributing to her income.



### **Financial Sustainability:**

The surplus income generated from goat rearing has become a crucial resource for Meena's family. She utilizes the excess amount to cover household expenses, providing financial stability and support for her husband and daughter.

### **Impact on Family Life:**

Meena's entrepreneurial spirit and the success of her goat rearing venture have transformed her role within the family. The additional income not only eases financial burdens but also empowers Meena to actively contribute to her family's well-being.

### **Gratitude towards ASSCOD and Omega:**

Meena expresses her heartfelt gratitude to ASSCOD and Omega for their micro credit program, which has changed the trajectory of her life. The program not only provided her with a means to earn but also instilled confidence and independence.

### **Conclusion:**

Meena's case illustrates the transformative power of targeted micro credit programs in empowering individuals to create sustainable livelihoods. ASSCOD and Omega's intervention have not only changed Meena's life but have also contributed to the economic empowerment of her family, demonstrating the positive impact of community-focused initiatives.



### 3. Women Employment through New Enterprises:

ASSCOD started a tailoring centre, wire bag unit and Jute bag unit with the support Omega Healthcare and HDFC. This programme benefitted the tribal women to developing their skills and helped them to earn an additional income. 72 tribal women participated in this training and 30 women started to earn income through selling their products like clothes, jute bags and wire bags.



## 4. Wings to Fly Trust – An initiative to economically empower tribal women



ASSCOD, in partnership with Omega Healthcare started a new project in the year 2022. This project was started mainly to address the poverty issues among the tribal families in 15 villages of Chengalpattu and Kanchipuram Districts of Tamilnadu. There was a discussion between ASSCOD and Omega Healthcare about the funds being disbursed on micro loans. ASSCOD submitted a concept paper on Omega microloan revolving fund and the same was approved. Based on the concept paper, it has been agreed by both parties that ASSCOD would form a trust with tribal women with the representatives from ASSCOD to collect the interest free micro loan and same will be deposited in Wings to Fly trust bank account. This fund will be managed by Wings to fly trust till the year March 2028. The revolving fund will be used to improve the infrastructure of target villages through implementing common programmes (Drainage channel, Street lighting, flushing bore well and installing electric motor with tanks, link road repairing and street solar lights installation. So, we formed the trust, got the PAN and 12A for the trust. A separate bank account will be opened soon and as per the advice of Omega Healthcare. It is proposed to transfer Rs.1,00000 for the independent management of the trust. The main aim of the formation of trust is to enable them to function independently from April 2028 onwards and to work with Government and likeminded organizations in parallel to ASSCOD.

## Education

### 1. Reverse Osmosis (RO) Plant at Government Girls Higher Secondary School

Sun Pharmaceuticals Pvt Ltd, in collaboration with ASSCOD, has successfully implemented a Water, Sanitation, and Hygiene (WASH) project. This initiative aims to provide clean water to 1920 girl students at the Government Girls Higher Secondary School in Madurantakam, Tamil Nadu. The Reverse Osmosis (RO) Water plant, built with a capacity of 1500 liters per hour, stands as a testament to Sun Pharmaceuticals commitment to community development and to attain SDG - 4.

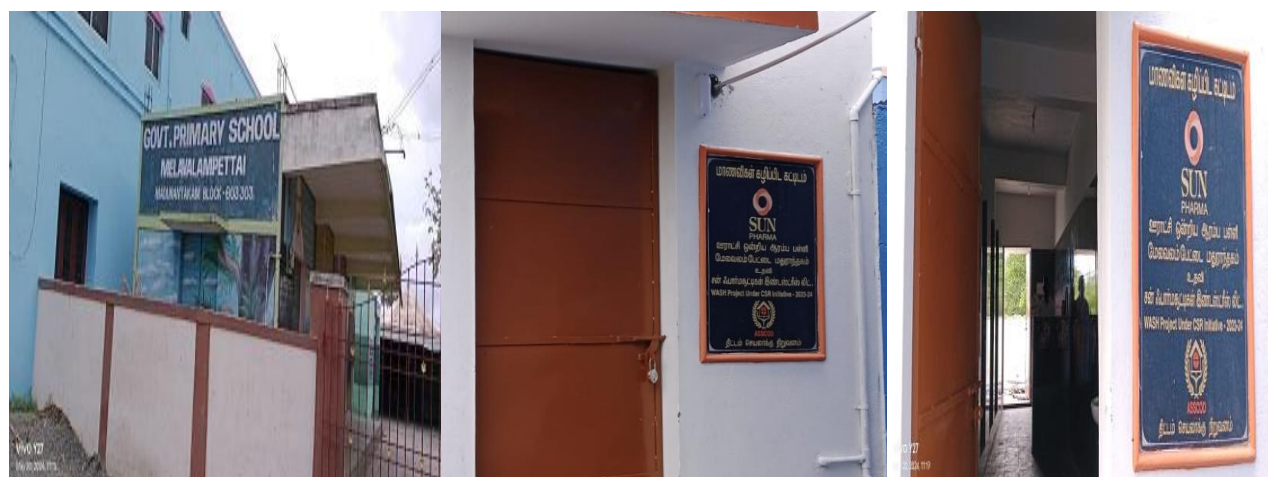


### 2. School Toilet Construction Program

We have been implementing various education programmes to improve the quality of education of the poor children in our target villages in Chengalpattu and Kanchipuram Districts of Tamilnadu.

The following table shows that the education programmes implemented during 2023-24.

Both schools are Government run schools where, due to lack of sanitation facility girls children enrollment have been declining and 20% of dropouts has been increasing. As we completed toilet construction programme in Melavalampettai Govt school, it is expected the enrollment would increase and dropouts would decrease considerably during the academic year 2024-25. This activity attained SDG -4.

Because of our scholarship support the children are continuing and performing well in their studies. In some of Govt. Schools where children are more in numbers without sufficient number of teachers. So, we engaged 2 teachers mainly to cover 10<sup>th</sup> and 12<sup>th</sup> std as they were appearing for public exams. This resulted in increased children passed out rate with good marks.

### **School Children Transportation support:**

In CSI school Karunguzhi, there are 28 tribal children studying. The distance between the village and the school is about 2 km and the children have to cross the GST road, which is highly risk for the children as the road is with heavy traffic. So, many children have become dropouts. Based on the request from the school Head Master, we supported the school to hire auto rickshaws to bring the children from their villages to school and back to village after school. This ensured 28 tribal children to continue their studies and to pursue high schooling.

ASSCOD with the funding support from Sun pharmaceutical started 5 evening tuition centres to benefit the children as per the details given below

As the tuition centres created visible impacts, neighboring village called Malaipalayam, the parents requested our NGO to open an evening tuition centre. So we opened a new centre and the details are below:

In the total, because of our tuition centres the children are studying well and spending their time meaningfully in the after school hours. This resulted in physical growth, mental growth improved performance in their studies.



## Health

### 1. Anemia Correction Programme

On 7<sup>th</sup> February 2024, we conducted an Anemia correction programme in a tribal village named Kallankollai in Chengalpattu District of Tamilnadu. The camp was conducted to impart medical advice and treatment exclusively to benefit the tribal families. Doctor V.Nisha raised awareness on personal hygiene, menstrual hygiene and the importance of nutritious food consumption. Also, 21 patients received medical treatment, drugs and medicine for various diseases.

## 2. Medical equipment and supplies donation (PHCs)

PHCs are playing key role in addressing the health issues of poor people in the remote areas. Though the centres are doing their services well, they don't have sufficient medical supplies, equipments and other infrastructure to cover more number of patients increasing day by day especially after Covid-19. ASSCOD with the funding support from Sun pharmaceuticals provided necessary medical supplies, instruments such as BP apparatus, Sugar meter and other necessary medical supplies to the PHCs in Jamin Endathur and Melavalampettai, Chengalpattu district of Tamilnadu.

### Impact

Both the centres are serving about 10000 families in the surrounding 20 Panchayats after our support the PHCs. Because of this support, the centres are extending quality medical services and that ensured the people to lead a healthy and disease free life.

## 3. Health services to adolescent girls

The Tribal Adolescent Girl children Development Project, initiated by ASSCOD (NGO), commenced on March 28, 2024, in Nelvoy Village. The project aimed to address the issue of malnutrition among adolescent girls belonging to tribal

communities residing in Nelvoy Village. Through a tailor made approach involving nutrition kits and training sessions, ASSCOD aimed to improve the health and well-being of these adolescent girls over a six months period project.



The decision to launch the project from the observation made by ASSCOD during a tailoring training session in Nelvoy village. It was noted that several adolescent girls from the tribal community, are malnourished. ASSCOD identified the urgent need to intervene and provide nutritional support to these girls. Malnutrition not only affects physical health but also impedes cognitive development and overall growth, which could have long-term consequences for the girls and their communities.

#### 4. Safe drinking water

In pudupattu Panchayat, Chengalpattu district, 1600 people struggled hard to get safe drinking water. So, with the funding support of Sun Pharmaceuticals, we provided safe drinking water through setting up 1500 LPH Reverse Osmosis plant which provides safe drinking water to all the people in this panchayat.



## Environment

### 1. Portable Solar Lights (PSLs) to tribal families

In the rural areas, especially in the areas where tribal people live, there is no electricity in majority of the places. The tribal women cook outside their houses and cook before sunset due to no access to electricity. The children also struggle hard to study in evenings after 6.00 pm. They have been using kerosene lanterns and many tribal families are not in a position to buy kerosene in the open market due to their inability to bear the cost. So, to address the electricity issues of tribal families living in extremely difficult areas, we provide them domestic solar lights.

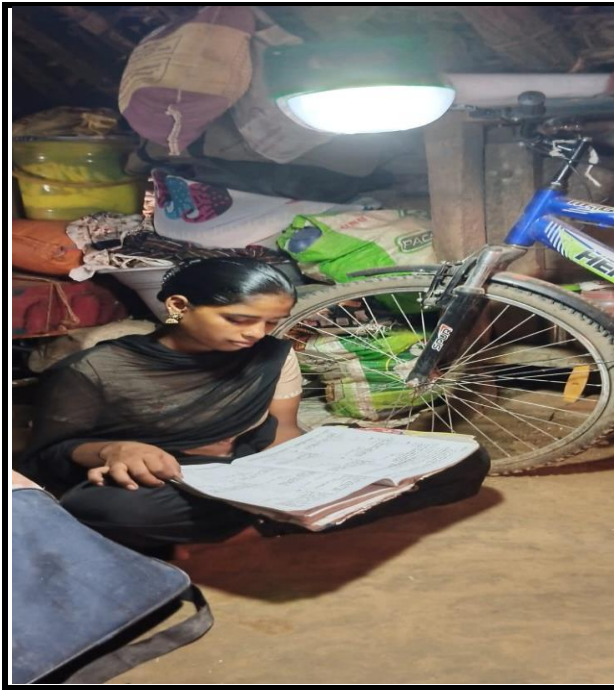
Our field staff identify the beneficiaries especially women and donate domestic solar lights. We have donated 1500 Portable Solar Lights (PSLs) to 1500 tribal families. They charge the lights for 4-5 hours every day and use the same in the nights for enabling children to study till 9.00 pm and to cook inside the houses (huts). Tribal Men use the solar lights in the night time to catch fish and for hunting. Tribal people are now happy because solar lights help the women to cook in the nights, children to study extra hours in the nights, men to use the solar lights to catch fish in the nights for earning additional income.

## Case Study 1



**Name of Beneficiary: Ramya**

**Village: Manampathi Sandhaimedu ,Uthiramerur Taluk, Kancheepuram District**

Ramya is a 17-year-old girl studying in the 12th grade. She lives with her family in a faraway village called Manampathy Sandhaimedu. Their house, like others in the village, didn't have electricity. This made it hard for Ramya to study at night, especially during the rainy season. But something good happened! ASSCOD and Schneider were very kind and donated them solar lights. This small change made a big difference! Now, even on dark, rainy nights, Ramya can study comfortably. She doesn't have to worry about missing out on her education anymore. Her younger brother Vishal also benefits from the solar lights. He can study well and do better in school. The solar lights make their nights safer too. Before, they had to use kerosene lamps, which were dangerous. But now, they don't have to worry about accidents. Overall, having solar lights at home brought happiness and relief to Ramya's family. They no longer feel limited by the lack of electricity. Now, they can follow their dreams without the darkness holding them back. It's a bright and new beginning for them.

## Case Study 2:



**Name of the beneficiary: Chinnaponnu w/o Paneer**

**Village: Manmpathy Kavangkarai**

**Uthiramerur Taluk, Kancheepuram District, Tamilnadu.**

Chinnaponnu and her husband Paneer, aged 61, are part of the tribal community living in the remote village of Manampathy Kavangkarai. Their livelihood depends on daily wage work, earning about 2000 rupees a month. Life in their village is challenging due to limited access to basic amenities like electricity. However, their lives changed for the better when solar lights were introduced. Before solar lights, Chinnaponnu and Paneer faced difficulties in the dark nights. Lack of electricity made daily tasks and safety challenging. But with solar lights installed, their lives improved. Solar lights also boosted their economic situation. They could work longer hours at night, earning extra income through activities like handicrafts. This eased financial burdens and provided stability. Additionally, solar lights enhanced their quality of life, fostering a sense of community and connectivity.

## Cyclone Relief Programme

In a collaborative effort aimed at making a meaningful difference in the lives of those most affected by cyclone disaster by cyclone named MICHAUNG. ASSCOD, in partnership with Omega Healthcare's CSR initiative, has successfully provided essential support to 170 tribal families across villages including Pudupattu, Vinayaganallur, Retaimangalam, Elapakkam, Nelvoy, and Perunkozhi. By distributing dry ration kits containing rice and basic grocery items, this initiative aimed to alleviate immediate concerns related to food security and lay the foundation for these communities to face the challenges of the disaster and ultimately return to a semblance of normal life.

### **Project Management**

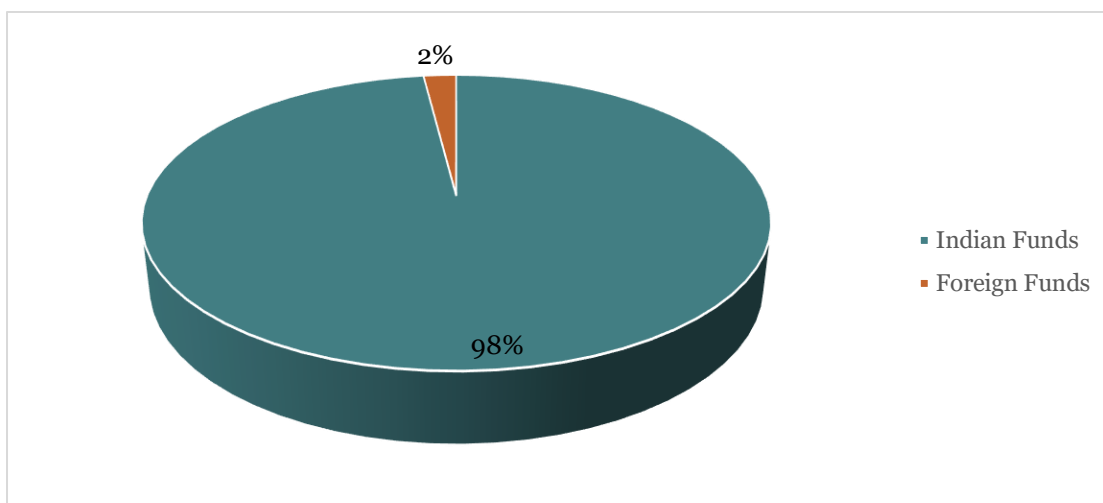

### Fund Inflow



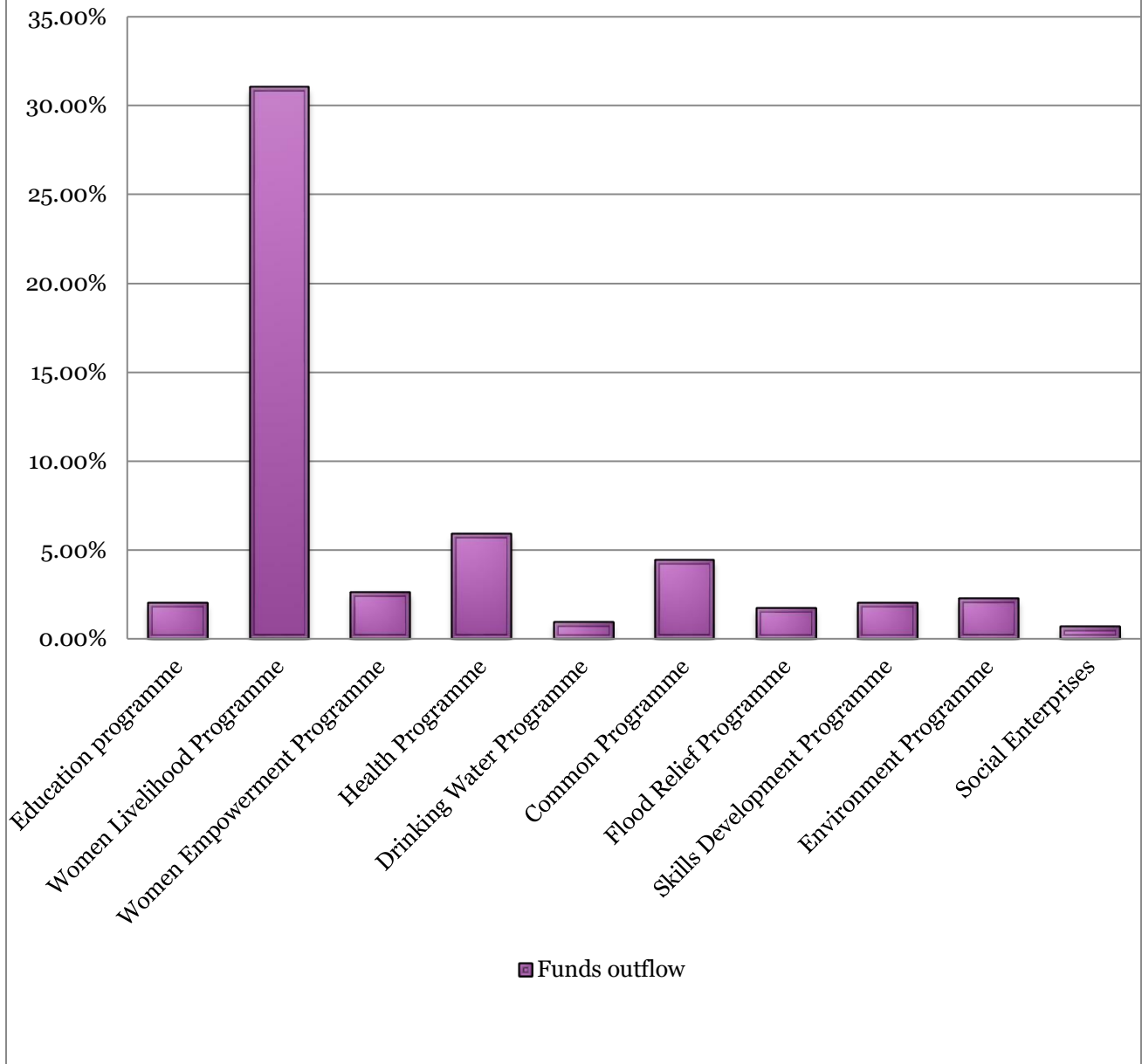

**SIGNIFICANT ACCOUNTING POLICIES**

1. The accounts are prepared on historical cost basis as a 'going concern' Grants and Payments are accounted for on accrual basis following generally accepted accounting principles and practice and Accounting Standards issued by the institute of chartered Accountants of India for NGOs wherever applicable, except otherwise stated.
2. Fixed Assets acquired/ received in kind are directly charged to expenses accounts and stated in the Balance Sheet through Assets Fund Account.

3. Fixed Assets are stated as under
  - a) Assets Directly acquired – at purchase cost less accumulated depreciation.
  - b) Assets received in kind – at stated / estimated costs less accumulated depreciation.
4. The consumables / Medicines and other related items acquired are charged directly to the expenses since as per the organization, the same are for free distribution and not to be sold hence has no value for them.
